

## STALLION CONTRACT FOR TRANSPORTED SEMEN

I, \_\_\_\_\_, hereby confirm my reservation to the Shagya Arabian stallion, BAYRAM, reg.#ShA-91-064 for the 200\_\_ breeding season. I understand and accept the following terms:

1. A veterinary certificate and current uterine culture taken when the mare is in heat and submitted to a recognized laboratory showing the mare to be in sound breeding condition and free of infection, is a condition for service.
2. A \$200.00 non-refundable booking fee. The balance of the breeding fee, which is \$800.00 must be received by the stallion owner before delivery of the semen.
3. I understand that my mare must be examined by a licensed veterinarian between 40 and 55 days after the last day bred and stallion owner notified of her pregnancy status at the time, or all live foal guarantees are null and void. I understand that my mare's breeding certificate must be signed and returned to the stallion owner within 10 days after the last 55 to 65 day examination of the mare or all guarantees are null and void.
4. The stallion owner assumes responsibility only to deliver live semen in viable condition at the time of delivery to the mare owner's farm or to the approved breeding station. The semen must be administered by a licensed veterinarian or by a breeding technician approved by the stallion owner. This approval constitutes a part of this contract, and without it, the live foal guarantee is null and void. The semen must be administered in the day of delivery or the stallion owner shall be considered to have fulfilled the contractual obligations and any guarantees in clauses #5, #6, #7 shall not apply.
5. This contract guarantees return privileges for the same mare if the mare is examined by a licensed veterinarian and found to be barren at 55 days from the date of the last service, If after two full breeding seasons the mare does not conceive, the mare owner may substitute another mare for one breeding season. This contract is not transferrable.
6. Should the mare not produce a live foal that stands and sucks, the mare owner shall be entitled to a return breeding. It will be necessary for the mare owner to pay a \$200.00 booking fee during the next breeding season in order to qualify for a return breeding. This guarantee shall only apply if the stallion owner is notified within 48 hours of the foal's death. A statement of details by a licensed veterinarian must follow within 10 days or the guarantee becomes null and void. This clause is also binding in case of abortion.
7. I understand that the mare owner shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, and therefore agrees to hold the stallion owner harmless or any all damages associated therewith.
8. I understand that the veterinarian who is to perform the insemination must contact the stallion owner by telephone before semen will be shipped. Failure to do so may absolve stallion owner of any obligations under this contract. It is absolutely essential that communication be established and maintained directly between the insemination veterinarian and the breeding farm. The success of the transported semen program depends upon the close cooperation between stallion owner and the veterinarian managing the mare.
9. Fee: Stud fee is \$800.00 plus \$200.00 nonrefundable booking fee totaling \$1000.00.
  - A. Mare owner will pay a fee of \$200.00 per collection for semen which is shipped to their mare. This fee is for the collection materials and semen preparation for shipping.
  - B. Mare owner understands that request for semen shipment must be made by 2:00 p.m. of the day preceding the requested semen shipment or the collection fee may be doubled and courier fees may be incurred for special delivery to the shipper.
  - C. Equitainers and semen shipping containers are disposable.
